Cllr Grantham reported that the girl's school are having problems with speeding traffic going through the lights and there have been a couple of near misses. There was a discussion about the calibration of the lights and whether it needed to be looked at. The PCSO agreed to follow this up.

Cllr Garbett reported that work on the budget is underway.

Cllr Grantham reported she has met with AESG eco council. A few ideas have been discussed including the possibility of having recycling waste bins installed in Alderley Edge. They are also looking at car share, compostable materials and customers bringing their own containers to shops.
